2. Hazards Identification

2.1. Classification of the substance or mixture

Classification under CHIP: Xi: R36/37/38; Sens.: R43; -: R52/53

Most important adverse effects: Irritating to eyes, respiratory system and skin. May cause sensitization by skin contact. Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

4. First Aid Measures

4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water.

Ingestion: Wash out mouth with water. Consult a doctor.

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

6.1. Personal precautions, protective equipment and emergency procedures

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid.
