2. Hazards Identification

2.1. Classification of the substance or mixture

Classification under CLP: Aquatic Chronic 3: H412; Eye Dam. 1: H318; Skin Irrit. 2: H315; Skin Sens. 1: H317; STOT SE 3: H335

4. First Aid Measures

4.1. Description of first aid measures
